Fixed minimum monthly payments equal to 4.7027% for 24 months, 3.3167% for 36 months, 2.6285% for 48 months, or 2.2194% for 60 months, of the promotional purchase amount will be required each month until the promotional purchase is paid in full, in addition to any other required minimum payment. Finance charges will be applied to promo balance at the fixed daily periodic rate of .03260% (ANNUAL PERCENTAGE RATE 11.90%) until the promo balance is paid in full.
